## Requirements

## All Camp Participants must be:

- Between the ages of 18 and28
- Either a student, teacher, youth worker, or capable of leading a specialized skill at camp
- Proficient in spoken and written English
- Comfortable working with children

#### How it Works





APPLY

Sign up and complete our short online application today! You'll just need to provide some basic information about yourself-mainly why you want to be a camp counselor!

Then you will have two interviews and if you pass, be asked to complete full application and upload a few documents



MATCH

Once accepted, camp directors will be able to view your application. They may contact you for an interview. We will have access to our network of partners to help place you at summer camps across America.

Once you receive an offer you're excited about, you're one step closer to the summer of a lifetime!



TRAVEL

After you accept a job offer, the process is simple. You'll get your documents for J-1 Visa sponsorship, travel arrangements, orientation, insurance, and other logistics. Before you know it, you'll be at camp doing that summer job you've been dreaming about!!



## What You'll Earn at Camp Camp Placement Participants

Age 18-20 earn a minimum \$1600 USD

Age 21+ earn a minimum of \$1750 USD



These stipends are all based on a nine-week (63-day) schedule. If your placement lasts longer, you'll be paid an additional \$30 for each additional day you work. And remember, your camp will also provide you with free housing and meals!

\*Federal, State and local taxes may be deducted from these stipends.

\*Your camp may more than the minimum and will specify in your job offer.

\*Accident and sickness insurance is included for the entire duration of your contracted dates.





## **Costs**

## Life at Camp

Camp is for the campers! The camp environment is a unique setting where every child has the opportunity to explore the outdoors, make new friends, and learn more about him or herself. In this setting, the counselor provides structure, safety, and fun. Camp is for campers and they must always come first.



## The Camp Environment



- Counselors must abide by all camp rules, including curfews. Camp rules and regulations are designed to provide a
  safe environment for all members of the community, and although they can be strict, they must be followed.
- Parents expect counselors to treat their children with dignity and respect. Taking care of someone else's child is a huge responsibility! Counselors must be mature enough to handle stressful situations in a positive manner.
- Being a camp counselor is a 24-hour a day job. If a child is sick in the middle of the night, a counselor must take care of the child. However, camps will give counselors at least one 24-hour time off period per week. Time off will vary from camp to camp. A counselor may get up to two nights off a week. This usually means a few hours off after the campers go to sleep, and not necessarily a full night off until morning. Many camps will also provide the participant with one period off during the day (approximately 45 minutes to one hour).
- Camp assignments can involve hard work, and shouldn't be treated like a vacation! Participants are here as cultural exchange visitors who are supporting their host camps, and need to make sure they're fulfilling their work obligations while gaining the full benefits of learning about and living in the U.S.
- Camps may have **strict policies regarding alcohol and/or smoking**. Participants who are not willing or not capable of following these rules should not apply. Failure to follow these policies often results in the participant being fired.







## What type of housing is provided?



 Camps have a variety of sleeping facilities: cabins, tents, A-frames, and dorms. Facilities range in ruggedness.

- Living facilities will be more rustic than participants may be used to. For example, there are some sleeping facilities with no electricity. Participants need to keep an open mind.
- The bathroom facilities may be within the cabin or in a centralized location. Either way, the participant will not have much privacy at camp.























## What type of food is provided?



- Be prepared for "Kid-Friendly American" food. Pizza, pasta, sandwiches, hotdogs, grilled cheese, tacos, french fries, cereal, etc. Juice, milk, and water to drink.
- A salad bar is usually available.
- Food prepared for a large group of people. Combination of fresh and processed foods.
- Usually served family style or buffet.
- Accommodate food allergies and dietary restrictions.

## Where are camps located?






- Most camps are located in the Northeast region of the United States. However you can be placed anywhere in the U.S.
- Camps are located far from major cities in rural, outdoor settings.
- Participants could be working in any area of the U.S. but most camps are located near lakes, rivers, mountains or forests. They are in some of the most beautiful locations in the country!
- Participants should keep an open mind and be ready for an adventure.
- Participants can search our camps by location and choose to apply to camps in a particular region but we can not guarantee placement at their preferred camp.

## Camp Visits

Our staff visits as many camps as possible in order to check on our participants and learn more about the camps. Visits are extremely beneficial to the placement process; once we have seen a camp, we have a clearer idea of the kind of person who would fit well there. During these visits, we generally tour the camp, speak to the director, and meet with all of our participants. While it is impossible for us to visit all camps, we try to rotate locations each year and see as many camps as possible. It is also important to note that the U.S. Department of State will conduct site visits to camps on some occasions.
